Report of the President

I wish all my brothers and sisters in our great Union a very happy and healthy new year!

In January 2021, the current officers along with the executive board and committee members were sworn into office and were facing four main issues that needed to be addressed immediately. First, was the Internal Revenue Service, for not having paid the correct amount of taxes owed and not having our taxes filed on time. Second, was the amount of money owed to the Negotiated Pension Plan (NPP). Third, was not having our LM2 Report filed on time with Department of Labor (DOL). Forth, was finding every way possible to keep our expenses to a minimum. Going into 2023, the Local was able to accomplish all four of our main issues. Our taxes are now in order, all back contributions owed to the NPP have been paid in full, the LM2 Report for the DOL has been filed, and we have been successful in cutting down on our Local expenses. I want to thank the officers and committee members for their hard work in helping to resolve these issues.

We are still facing another important area of concern; this area is with our membership's participation in our Local. In September 2022, we made available the convenience of attending the Union meetings virtually by using Zoom. Members only need to request to attend the meeting by sending an e-mail

(from their personal account) to the Local two days prior to the meeting date and the invitation to attend the meeting will be sent back to them. Your Union will work better if everyone takes time to be involved.

Members receiving their *Bulletin* by U.S. Postal Service will receive their 2023 membership card with their *Bulletin*. Members receiving their *Bulletin* by email will also receive the January *Bulletin* by U.S. Postal Service along with their 2023 membership card. Did you know that during World War I, Columbia Typographical Union members responded to the call of their country's president and entered the armed forces in record numbers. With their brothers and sisters in other International Typographical Union (ITU) locals, they purchased over \$3,000,000 worth of Liberty Bonds, moving former President Theodore Roosevelt to write, "I take off my hat to the ITU."

In 1953 the first strike in 48 years involving 31 com-

mercial printing plants and 500 printers added \$171,600 annually to the wages of these Washington job printers. The strike lasted 17 days.
