Vice President's Report

Our May meeting gives members the opportunity to propose changes to our bylaws. In order to do this, you must show which bylaw you wish to change. For example: Article V, Section 1. Regular meetings shall be held at [10 a.m.] 9 a.m. on the third Saturday of January, May, September, and November.

As you can see, you must include the article and section you wish to change. You can also submit a new paragraph to a bylaw, but it still must be in the same article and section. A new section can be proposed.

All bylaw changes must be given to the Laws Committee before or during the May meeting. Once submitted the Laws Committee will meet to see if the changes are worthy of the change. They may or may not recommend the change. They may recommend a change with an amendment of their own. At the September meeting the Laws Committee will go over their report and the members can discuss the Laws Committee report and agree or disagree with that report.

The next step will be going before the whole membership to vote on the changes by referendum vote. The members have the final say in whether a bylaw should be changed or not.

BYLAWS REFERENDUM RESULTS FROM THE FEBRUARY 28, 2024 BALLOT

The Laws Committee comprised of Michael Divver, *Chairman*, Richard Anderson and Dolores Slack counted and certified the following results.

Delete matter in [Bold Brackets] and Insert matter in Bold Italics

Proposal No. 1-2023---ARTICLE VI--Quorum

[Add Section 2]

SECTION 2. Provided that the Local Union has made available a functioning video-conferencing platform that can verify the identity of members (the "invitation" process), members who are in good standing who choose to attend a regularly scheduled or special meeting of the Local Union via video conferencing software shall be included in the quorum count and shall have full participatory rights and privileges had they been physically present.

Proposal No. 2-2023---ARTICLE XIII--Executive Board

SECTION 1. The Executive Board of the Local Union shall consist of the President, Vice President, Secretary-Treasurer, [two members from the Government Publishing Office, and two members from chapels besides the Government Publishing Office are not available to serve on the Executive Committee, all members on the Executive Committee may come from the Government Publishing Office] and four (4) members elected at large from the entire membership of the Local Union.

Proposal No. 3-2023---ARTICLE XIII--Executive Board

SECTION 5. A quorum of four (4) Executive Board members [will be] is required to hold an official meeting of the Executive Board. If a video-conferencing software platform is available, the presiding officer shall have authority to permit the Executive Board to meet utilizing this method of telecommunication.

Proposal No. 4-2023---ARTICLE I--Names, Jurisdiction, and Objectives

SECTION 5. The Local Union shall not be dissolved, or its charter surrendered [so long as eight members determine to preserve the organization] except under the procedural steps outlined in Article XIII of the CWA Constitution.

Proposal No. 5-2023---ARTICLE II--Local Structure

SECTION 2. The membership shall consist of [employees working in the graphic arts, printing, publishing, electronics and communications industries] individuals working under collective-bargaining agreements negotiated by this Local Union (active members), individuals engaged in organizational activities within the jurisdiction of the Local Union, retired or disabled individuals (inactive members), and such other classifications of membership as provided for by the CWA or as determined to be in the best interests of the Local Union.

Proposal No. 6-2023---ARTICLE II--Local Structure

SECTION 6. The chairmen of GPO chapels shall constitute a committee to be known as the GPO Chairmen's Chapel. It shall meet before the regular Local Union meeting and in special session at the call of its chairman (also known as the Union Steward of the GPO bargaining unit), to discuss conditions in the trade relating to their various chapels and make written reports to the union. The committee [will] shall be governed by its Bylaws.

I [promise] affirm to [faithfully] diligently discharge my duties according to the Bylaws and Rules of the Local Union and the Constitution and policies of the [Union] CWA. I further [promise] affirm to give my successor in office all books and records in my possession. I shall at all times endeavor to serve my Local Union and the Communications Workers of America to the best of my ability, so help me God].
